#### RICHMOND COUNTY BOARD OF SUPERVISORS MARCH 10, 2016

#### **MINUTES**

At a regular meeting of the Board of Supervisors for Richmond County, Virginia, held on the 10th day of March 2016, thereof in the Public Meeting Room of the County Office Building.

#### CALL TO ORDER

Chairman Sanders called the meeting to order at 9:00 a.m., gave the invocation, and led in the Pledge of Allegiance. Chairman Sanders publically thanked everyone for their assistance during the recent tornado. (Attachment 1)

#### **SHERIFF**

Sheriff Smith presented the following report for the month of February: 640 calls for service; served 239 civil papers; served 31 arrest warrants with 51 warrants served; and served 42 traffic summons. He said that the jail population this week for Richmond County was 13.

Sheriff Smith reported that one of their police vehicles were hit by a state unit while working a recent accident. He said that he will keep Mr. Quicke informed regarding the repairs.

Sheriff Smith reported that during the recent tornado that affected the Naylor's Beach and Simonson areas, his staff worked through the incident, along side of fire and rescue, and participated in the clean-up operation on March 5<sup>th</sup>.

#### ANIMAL CONTROL

Sheriff Smith presented the following Animal Control report for the month of February 2016: 1 wildlife call; 15 dog calls; 16 dogs transferred to the pound.

Sheriff Smith said that the Animal Control Officer responded to 47 deputy calls and served 2 papers.

#### TREASURER

Kristie Brann, Treasurer, presented the Trial Balance Report for the month of February, 2016.

Mrs. Brann said that they have placed 504 DMV stops on delinquent personal property accounts. She informed the Board that the land sale will be held on March 12, 2016 at Rappahannock High School at 10:00 a.m. She reported that there on 19 parcels up for sale.

#### **COMMISSIONER OF THE REVENUE**

Jennifer Delano, Commissioner of the Revenue, reminded the citizens that state income and personal property forms are due by May 2, 2016.

Mrs. Delano said she is hoping for a good turnout at the upcoming land sale.

#### CHIEF OF EMERGENCY SERVICES

Chief Baker presented the following EMS report for the month of February: 113 calls in Richmond County; 1 call for mutual aide into Richmond County; 5 calls for mutual aide to bordering counties; and 2 fly-outs.

Chief Baker reported that \$25,062 was collected during the month of February for EMS recovery billing.

Chief Baker said that since his staff started handling the delinquent accounts, they have recovered \$5,503 and verified \$10,133 in write off accounts.

Chief Baker reported that on March 7<sup>th</sup>, they responded to a single vehicle accident in the Village area, which resulted in a triple fatality.

Chief Baker briefed the Board on the February 24<sup>th</sup> tornado and said that he continues to work with homeowners and contractors to make sure that all demands are met. Chief Baker thanked all of the responders involved for acting quickly and professionally.

Mr. Quicke thanked all of the organizations that assisted in the recent tornado. He said from the county level, they managed very well, but learned things that can be done differently in the future.

#### PUBLIC COMMENT

There was no public comment.

#### DR. TED TWEEL - THREE RIVERS HEALTH DISTRICT

Mr. Ted Tweel, Director of the Three Rivers Health District, introduced himself to the Board and thanked them for their assistance over the years. Mr. Tweel briefed the Board on the annual report and talked about the importance of prevention.

Mr. Thomas commended the Richmond County Health Department on being so helpful to the public.

#### FONES CLIFFS UPDATE - MR. ROB SMITH

Mr. Rob Smith, Attorney for the Fones Cliff's Development, updated the Board on the status of the project. Mr. Smith said that he has received many calls from people all over the country seeking information about the golf course. He said he has changed his philosophy from selling lots to building a world class golf course.

#### TIRE DISPOSAL OPTIONS

Mr. Quicke said he has met with Sam Johnson and Kathy Clarke from the Northern Neck Soil and Water Conservation Office regarding the tire disposal. He said that they have talked to Emmanual Tire from New Kent County, which will bring an enclosed 53' trailer to the Indianfield Trash Site for \$1,200 and leave it for as long as needed. Mr. Quicke if the trailer is packed neatly, it will hold approximately 1000 tires. He said that the annual Household Disposal Day is scheduled for May 14<sup>th</sup> and if the Board agrees, they can accept clean and off the rim tires, from private residents, on that day as a trial run.

Mr. Thomas said he would like to offer this service to the citizens at no charge, at least for the first time. Mr. Quicke said they will have to see what the demand is.

Chairman Sanders recommended using the trailer for the one day and if the trailer is not full, possibly leaving it on site for longer.

Mr. Quicke said that he will request that trustees from the Northern Neck Regional Jail be on site that day to help pack the trailer.

#### RAPPA POINT ROAD - 2016 TAX ASSESSMENTS FOR AFFECTED PROPERTIES

Mr. Quicke said that Mrs. Delano asked him to include on the agenda the consideration of decreased assessment for the 2016 tax year on all affected properties along Rappa Point Road, whether destroyed or severely damaged. Mr. Quicke said that in the past during such events, Richmond County has decreased the value of improvements for destroyed homes to 50% and the value of damaged homes to 75%.

Mrs. Delano told the Board that during Hurricane Isabel, there was an application process used to better access the damage. She said she has revised the form and she told the Board that no one has contacted her at this time regarding assessments on the damaged properties, but she is just trying to get a head start. Mrs. Delano asked the Board for guidance. Chairman Sanders recommended sending a letter to the property owners instead of advertising in the newspaper.

Mr. Pemberton asked if any of the damaged properties have occupancy permits. Mrs. Delano said that all of the properties on Rappa Point have occupancy permits except one lot. Mr. Pemberton said that none of the houses are livable since the tornado. He asked what the procedure is for a fire. Mrs. Delano said that if there is fire damage after January 1<sup>st</sup>, they are still taxed.

Mr. Herbert suggested coming up with a policy. Mr. Thomas agreed. Mr. Pemberton said in his opinion, the percentage should be 20%, even if it will cost the county more. He said the ones affected have lost enough.

Mrs. Delano said if the Board decides to proceed, she asked that an expiration date be considered on the applications in order to give her staff time to process.

Chairman Sanders asked Mr. Quicke to work on a policy and add it to next month's agenda. The Board agreed by consensus to continue discussion next month.

Mr. Quicke asked the Board about waiving building permit fees. The Board agreed that waiving fees should be part of the policy.

#### RAPPAHANNOCK HIGH SCHOOL – AFTER PROM REQUEST

Mr. Quicke said that he received a request from the Rappahannock High School After-Prom Committee asking the Board to contribute to the after prom celebration.

Mr. Quicke said it is a great idea; however, that is why there is a designated fund balance. He said the Board can designate money however the Board wants. Mr. Quicke said they can create an account for donations; he would just need to work with the Treasurer regarding the set up.

Mrs. Livingstone told the Board how Social Services handle donations. Mr. Quicke agreed that Social Services should handle individual assistance. He said that Mr. Thomas is suggesting that the donated funds be used for mainly the expenses of the clean-up for future disasters. Mr. Quicke said he is willing to work with Mr. Thomas regarding this set-up.

Mr. Parr thanked the emergency personnel and the County Administrator for all of the hard work they provided during the recent tornado. He said he is proud to be part of Richmond County.

Mr. Herbert thanked everyone for the hard work during the tornado and especially thanked Greg Baker for the countless hours he spent in the Rappa Point area. He said it makes him proud to see how the community came together during a difficult time.

Mr. Quicke thanked the Board for their help and assistance during the recent tornado.

Richmond County Board of Supervisors Minutes: March 10, 2016

Chairman Sanders called the meeting back to order.

#### RICHMOND COUNTY SHERIFFS OFFICE

Sheriff Smith explained his FY17 budget request to the Board, which included increases to the following line items: longevity scale, part-time dispatcher, Secretary 1 position, maintenance contracts, dues and memberships, and the Rappahannock Criminal Justice Academy.

Sheriff Smith asked requested a \$4,000 increase in the Animal Control Officer position. He explained that the position is a sworn deputy position and the increase would put him in the pay range of the other sworn deputies.

#### RICHMOND COUNTY VOLUNTEER FIRE DEPARTMENT

Chief Passagaluppi requested level funding for the FY17 budget. He provided the Board with a list of future needs of the Fire Department.

#### RICHMOND COUNTY DEPARTMENT OF EMERGENCY SERVICES

Mr. Paulette, Captain, requested level funding for the FY17 budget, with the exception of continuing the retention plan with the implementation of the hazardous duty multiplier for VRS. Mr. Paulette also requested an EMS software line item be added to the upcoming budget to cover the costs of possibly having to purchase new reporting software.

#### RICHMOND COUNTY YMCA

Phillip Belfield, Branch Executive, thanked the Board for their past support and asked the County to restore its original contribution of \$35,000 due to expected need increases in 2016.

#### NN-MP COMMUNITY SERVICES BOARD

Mr. Walsh thanked the Board for their continued support and asked the Board for an overall increase of \$5,426.

#### RICHMOND COUNTY PUBLIC LIBRARY

Mr. Ream thanked the Board for their past support and requested \$91,160 for the FY17 budget, which is a \$5,000 increase.

#### RICHMOND COUNTY DEPARTMENT OF SOCIAL SERVICES

Mrs. Livingstone requested level funding but informed the Board that the Department must hire a new attorney which will likely be at a higher hourly rate than they have been paying. She said she plans to fill a vacant position in FY17.

Mrs. Livingstone said that she has spent several hours reviewing CSA reports from 2008 to present and has determined that Richmond County has been paying Medicaid for Richmond City kids. She said that Richmond City owes Richmond County \$485,279.36 in Medicaid reimbursements.

#### THE HAVEN

Ms. Weakley thanked the Board for last year's generous contribution and requested \$10,000 for the FY17 budget. She explained that the funds help support the costs, which provide the necessary resources to help individuals who reside in Richmond County.

#### RICHMOND COUNTY VOTER REGISTRATION

Ms. Keyser is requesting level funding for the FY16-17 budget.

Ms. Keyser provided the Board with a comparison sheet of the expenses between the November 2015 Election and the March 2016 Primary. She said March primary expenses totaled \$5,297.93, which was a saving of \$6,876.28 over the November election.

Mr. Quicke said that part of the November expenses was included in expense of the new voting machines. He said that he is pleased that staff is now able to handle situations that the County would usually have to pay for.

#### RAPPAHANNOCK LEGAL SERVICES

Anne Clockner thanked the Board for past support and requested from the Board \$2,467, which is level funding.

#### RICHMOND COUNTY COMMONWEALTH'S ATTORNEY

Mrs. Trible requested from the Board \$60,275 for the FY17 budget. She said is in the process of applying for a grant for a Victim-Witness position, which if awarded, she anticipates a large reduction in the salary that she is requesting for the Secretary/Victim-Witness position.

Mr. Quicke explained the previous arrangement in the Commonwealth Attorney's Office, which included three County employees and one full-time employee that was paid strictly by a grant. He said with the new set-up, there are two full-time county paid employees and one full time that will be paid by a grant. He said that this set-up, due to the staffing changes and grant position, will save between \$20,000 and \$30,000. Mrs. Trible stressed that even though they have reduced the staff, she feels like the office is running more efficiently.

#### NORTHERN NECK SOIL AND WATER CONSERVATION

Mrs. Clarke requested \$15,000 in funding for the FY17 budget. She said that this request amount reflects a \$5,000 increase over the current allocation, which represents level funding

afforded to them by the County's prior to budgetary reductions made in FY14-15. Mrs. Clark provided the Board with last year's annual report.

#### RAPPAHANNOCK COMMUNITY COLLEGE

Mr. Doyle requested \$20,600 from Richmond County for the FY17 budget.

Ms. Annette Hamilton briefly told the Board about the education and experience she and her son are receiving from Rappahannock Community College.

#### RICHMOND COUNTY PUBLIC SCHOOLS

Dr. Smith presented his proposed budget to the Board. (Attachment 2)

Mr. Herbert asked Mr. Smith to explain his proposal for carryover funds. Dr. Smith said has talked to Mr. Quicke about starting a CIP for the purpose of locating carryover monies from the fund balance. Dr. Smith said that many schools do this and it is a proven way for the schools and county to account for funds not spent.

Chairman Sanders thanked Dr. Smith for his presentation.

Chairman Sanders asked the members to contact Mr. Quicke regarding any ideas or changes before next week's work session.

Chairman Sanders called the meeting back to order.

Mr. Quicke said that after speaking with each member over the past week, no changes have been made to his proposed FY17 budget.

Mr. Quicke briefly went over the highpoints of his proposed budget, including:

#### Planning for the future

- Recommended \$0.03 Real Estate Tax Increase (\$0.70/\$100)
- \$0.01 = \$75,000 Capital Improvement Plan
- \$0.01 = \$75,000 Future NNRJ Liability
- \$0.01 = \$75,000 Fund Balance Contribution

#### Investment in Personnel

#### County Personnel:

- 2% salary increase effective December 1, 2016
- Continue implementation of Retention Plan for Richmond County Sheriff's Office
- Continue implementation of Retention Plan for Richmond County Department of Emergency Services
- 1 recommended additional full time position EMS
- 2 recommended part time positions Admin, Properties
- No recommended changes to employee health insurance
- 0% increase to health insurance costs

#### Richmond County Public Schools:

- Teacher salary scale step increases effective July 1, 2016
- Employee/Teacher 1% raises effective December 1, 2016
- Bus Driver 2% raises effective December 1, 2016

#### Other Recommendations

- Commonwealth's Attorney Case Management Software
- Sheriff's Office Vehicles (2) to be financed through a local bank
- Increase to Solid Waste Budget for increased disposal amounts
- Department of Emergency Services Billing Software

Mr. Quicke told the Board that it is important to dedicate more to the Capital Improvement balance.

Mr. Thomas asked about the debt payment for the schools. Mr. Quicke explained that the Courthouse construction payments total \$400,000 a year and will be finalized in 2020. He said that is has been worked out that \$300,000 of that \$400,000 will go towards the school loan, leaving \$100,000 available.

Mr. Quicke asked about the costs associated with real estate twice-a-year billing. Mr. Quicke said it will cost between \$50,000 and \$60,000 a year. Mr. Quicke said additional costs involved in this process will be the mailings and substantial improvements to the IT networks, which is why twice a year billing is being proposed in 2018. He said that both the Treasurer and the Commissioner of the Revenue are willing to work with this schedule.

Mr. Herbert questioned the software. Mr. Quicke explained that there is software out there that can be purchased for about \$100,000. He said that Chris Jett is willing to build the system that is needed to make the two offices compatible with each other.

Mr. Herbert said he didn't realize that software was so expensive. He asked what the County would do if something happened to Chris. Mr. Quicke said that Chris is very important to Richmond County and that is also a concern of his. He said that Chris needs help with the smaller issues so he can spend more time on the County'larger needs.

Chairman Sanders asked Mr. Quicke to explain the \$0.03 tax increase and where we will be next year. Mr. Quicke said that he doesn't think it will take a tax increase to balance the budget in FY18. He said that there will always be operation issues that come up; therefore, it is better to budget capital and contingency funds.

Mr. Thomas asked about an additional Bay Transit bus. Mr. Quicke said that in order to purchase a ½ bus, it would cost around \$18,000. Mr. Quicke said he hasn't talked to Westmoreland in detail about the possibility.

Mr. Thomas said he is uncertain about the future funding for the NNRJ. Mr. Quicke said in his opinion, the NNRJ funding is the least important at this time. He said that the NNRJ fund balance is currently \$4,000,000 and that number will continue to decline. Mr. Quicke explained that the funding of the NNRJ is coming but they are currently talking to Gloucester County about buying into the jail.

Mr. Thomas said that the County gives the YMCA \$25,000 a year. He said that the YMCA uses the schools for free and asked Dr. Smith if he knew how much the YMCA's uses cost the schools. Dr. Smith said that the Y is the sole occupant of the 8<sup>th</sup> grade building at the Intermediate School, which is used pretty hard. He said that they pay no fees and it is expensive to maintain the facilities. Dr. Smith said that the YMCA has requested that the school update the Heating and AC unit, which would cost be \$7,000-\$8,000. Mr. Thomas confirmed that the YMCA gets \$25,000, plus the use of the schools seven days a week.

Mr. Parr said that the YMCA is a business, but Richmond County doesn't have a Recreation Department; therefore, if that is all that it is costing the County to give the kids something to do, he thinks it is worth it.

Mr. Pemberton asked if a \$0.03 tax increase is advertised, can they reduce that amount after the public hearing. Mr. Quicke said yes, it can be reduced after the public hearing, it just can't be raised. Mr. Pemberton said he would rather advertise the \$0.03 increase and see what the public response is.

Chairman Sanders said he would like to advertise the \$0.03 and apply \$0.02 to the Fund Balance and \$0.01 to the Capital Improvement Plan. He said that he thinks that the NNRJ funding can be put off for this year.

Chairman Sanders asked Mr. Quicke to go over affect a tax increase will have on the property owner. Mr. Quicke reviewed the following chart showing the cost of a \$0.03 tax increase to a homeowner:

Mr. Thomas reminded the Board that having taxes due twice a year would be a one-time fix. Mr. Quicke said that this would require a public hearing and if approved, the process would require a strict fund balance policy to be in place by the Board.

Mr. Parr asked if the \$0.01 was designated to a NNRJ special fund and if the Gloucester deal went through, could that money be designated for another use. Mr. Quicke said that money can be undesignated, then re-designated for other uses.

The Board commended Mr. Quicke for his effort and time spend on the budget. Mr. Quicke said he works on the budget all year long and tries to make the process as easy for the Board as possible.

Chairman Sanders asked the members if they are ready to move forward.

#### FY17 Budget - Positives

- State Funding for Education
  - This year's top priority of both the Governor and General Assembly is more State dollars back to the localities towards education.
- Education funding was severely cut at the State level from 2008-2010, of which the localities were forced to contribute more local dollars into education to make up for those losses.
- This will be the first substantial investment into K-12 education since the recession and results in approximately \$300,000 of additional State Revenue back to Richmond County,
- Drop in Local Composite Index (LCI)
  - Our LCI for the 2016-2018 Biennium has dropped from .3364 to .3180
  - Our LCI dropped from .3599 to .3364 in the 2014-2016 Biennium, which resulted in an additional \$270,000 from the State to the County.
  - This years drop is not as significant, but still equates to roughly \$200,000 of additional revenue from the State to Richmond County.
