FY15-FY19 CIP Addendum

Richmond County, Virginia



The first edition of the Richmond County Capital Improvement Plan (CIP) was implemented for FY14-FY18 by the Richmond County Board of Supervisors. The CIP is a very important financial planning document that allows the County to plan future capital expenditures years in advance, rather than only addressing these large expenditures as they arise. It is a resource that should be used to compliment the County's Comprehensive Plan and it is also a tool that the citizens of the County should see on a regular basis so they are aware of the needs of the County.

Much like the Comprehensive Plan or the Annual Operating Budget, the CIP must be heard and approved at a Public Hearing of the Board of Supervisors which gives the citizens the right to be involved in the process and allows their input to be heard and considered.

Even though an item may be listed to be funded in a certain year, this does not mean that the item will actually be funded. Funding for CIP projects is dependent upon money being allocated to them from the annual operating budget that is approved every spring by the Board of Supervisors. In the FY14 Budget, which runs from July 1, 2013 through June 30, 2014, the Board of Supervisors dedicated \$23,332 to the CIP.

Much of the revised FY15-19 CIP is the same as the FY14-18 Plan. Any items that were not funded in the current year (FY14) have been shifted to FY15 funding. Below is a comprehensive listing of all projects listed on the FY15-19 CIP Spreadsheet. <u>Please refer to the FY14-FY18 CIP document for project descriptions of projects previously submitted for inclusion into the CIP.</u> All new requests for the FY15-19 CIP are shown in red below.
